GUIDELINES FOR AVAILING SUBSIDIES ON DIFFERENT MARKET INTERVENTION SCHEMES UNDER STATE PLAN

OBJECTIVES:


The objective of the schemes are to encourage trading of pineapple and other horti. commodities outside state or country to enable farmers to realize better remunerative prices for their produces.

Eligible Sectors:-The scheme is applicable to Pineapple, Jackfruit and Lime/Lemon trading outside Tripura State.

Eligible Organization: The individual entrepreneurs/farmer, group of entrepreneurs/farmers, associations, co-operative societies, Self- help groups, non –government organizations are eligible for assistance under the scheme.

Conditions for eligibility-

- i. The Applicant should produce the copy of the supply order with buyer details to the undersigned along with application.
- ii. The copy of the supply order duly appraised by the seller/ related grower of the commodity along with quantity of supply against the supply order.
- iii. The appraisal report should be authenticated by concerned Agri Sector officer/subdivision officer/district Officer /Officer of Directorate of Horticulture &Soil Conservation, Agartala of the area.
- iv. If the commodity is procured directly from any trader, trader should appraise the quantity supplied by him /her with address details and his trading license/copy of vendor registration certificate under MNC /Municipal Council/Notified Area Authority within Tripura State.
- v. Application should be made at-least 5 days before transportation of commodity outside state with a request to inspect the commodity movement by concerned sector officer/authorized officer of the area on a pre-fixed date. (For ongoing trading before this guidelines is published application for such subsidy shall be considered after recommendation of a constituted committee. This application is only an intimation to the authority to examine the primary eligibility on confirming such movement of commodity.
- vi. A single applicant can avail subsidy for a maximum quantity of 10000 MT /season (for pineapple, twice in a year once for Queen and once for Kew)
- vii. An applicant can avail the subsidy either on transportation or on packaging materials not both at a time during the same season.



- viii. No further proposal from the same applicant/organization/individual shall be entertained beyond 10000 MT during each season.
- ix. Applicant should mention the vehicle/railway /airway details etc. used for transportation along with copy of challan etc. in support of such transportation.
- x. Applicant should also attach the inspection report of Sector Officer/subdivision officer/district officer/ authorized representative of Director of Horticulture, Govt.of Tripura in support of movement of commodities along with still photograph of the vehicle /photograph prior to loading into vehicle/railway /photograph of commodities packed at related air cargo station.
- xi. Subsidy @Rs.5000 /MT of product transported min for 100 km beyond Tripura border shall be eligible for subsidy.
- xii. Subsidy @Rs.5000 /MT of product packed in packaging materials(If CFB min 3ply to be used with maximum volume capable of holding maximum 10 kg commodity in a single container and min 6 kg in each/plastic container with min capacity of 10 kg and maximum of 20 kg in each plastic container) for transportation outside state, min for 100 km beyond Tripura boarder shall be eligible. for subsidy. Applicant should mention the vehicle/railway /airway details etc used for transportation along with copy of challan etc. in support of such transportation.
- xiii. Application for subsidy along with all necessary documents may be submitted within 7 days of transportation against each movement to Director of Horticulture & Soil Conservation, Paradise Chowmuhani, Agartala, PIN-799001 to enable payment of subsidy to beneficiary account after scrutiny of documents.
- xiv. Identity documents of buyer and seller should be submitted.

Release of subsidy:-

The approved subsidy shall be released to the respective Bank Account of concerned entrepreneur/farmer, group of entrepreneurs/farmers, associations/buyer/trader, co-operative societies, Self- help groups, non – government organization after scrutiny of all related documents by a committee and after issuing of certificate (ANNEXURE – II)
